The following Quality Requirements shall be applicable to Purchase Orders issued by PCI Manufacturing LLC as noted on the Purchase Order document. These requirements as described in the applicable clauses below shall supplement the requirements specified on the Purchase Order and its attachments, referenced documents, drawings, and specifications.

PQA 001	Non-Conforming Product	The Supplier must notify PCIM of all Non-Conforming Products. Direction will be given upon notification.
PQA 002	Product Change Notification	The Supplier agrees to notify PCIM of changes to their processes, products, or services, this includes any changes in the Supplier's external providers or location of manufacture and must obtain PCIM's approval.
PQA 003	Vendor Facility Access	The right of access by PCIM, their Customer, and Regulatory Authorities to the applicable areas of Facilities and to applicable documented information, at any level of the supply chain.
PQA 004	Sub-Contractor Pre-Approval	If The Supplier plans on using Sub-Contracting, PCIM must pre-approve.
PQA 005	Sub-Tier Flow Down	The Supplier must flow down all applicable Requirements to Sub-Tier Suppliers including customer requirements.
PQA 006	Subject to Source Inspection	PCIM or Its Customer may require a Source Inspection prior to shipment of Product.
PQA 007	Record Retention Clause	The Supplier must retain documented information, including disposition requirements and maintain Records for 10 Years unless otherwise stated by Purchase Order.

PQA 010 C	Material Certification Required (C)	The Supplier must provide Material Certification with Chemical properties.
PQA 011	Test Reports Required	The Supplier must provide Test Reports for purposes of design approval, inspection/verification, investigation, or auditing. These reports must contain the title, signature and date of the authorized supplier representative.
PQA 012	Material Safety Data Sheet (MSDS)	The Supplier must provide Material Safety Data Sheet (MSDS).
PQA 013	ISO 9001:2015 Compliant	The Supplier must be ISO 9001:2015 Compliant. This must Flow Down to any Sub-Tier Suppliers.
PQA 014	ISO 9001:2015 Certified	The Supplier must be ISO 9001:2015 3 rd Party Certified.
PQA 015	AS9100 Compliant	The Supplier must be AS9100 Compliant. This must Flow Down to any Sub-Tier Suppliers.
PQA 016	AS9100 Certified	The Supplier must be AS9100 3rd Party Certified.
PQA 017	Drawings Provided	PCIM will provide Drawings for the ordered Product.
PQA 018	Chain of Custody	The Supplier shall supply all material certifications, packing lists, test reports, and any other documents that ensures a full chain of custody of the raw material. This documentation will contain Heat Numbers, Lot Numbers, or Batch Numbers, etc. for traceability of the raw material or items from the original manufactured source to the end user, and all stops in between.
PQA 019	Cage Code Requirements	The Supplier with each shipment will provide the Manufacturer's Commercial and Government Entity (Cage) Code. The Supplier will legibly identify and record the Cage Code on the Supplier's shipping documentation and applicable certification documents. If the Manufacturer does not have a Cage Code, the Supplier will annotate the Shipper and Certifications.
